Otherwise, additional charges may be applied with customer approval.

Trenching or below ground electrical work, alternate installations than outlined, DOT regulations, landscaping or concrete repair, customerfurnished equipment, utility and service upgrades, repairs to existing electrical equipment, arc-flash and short-circuit studies, non-operational/ defective materials, abatement of hazardous materials, significant project delays, drywall cutting or patching, work on energized equipment, core upgrades to existing circuits, boosting of cellular signal, traffic control, and utility fees. Equipment and network pricing are subject to change.

EV striping, ADA accommodation, bollards, wheel stops and signage are optional per site.

CLARIFICATIONS

1. Permitting does not include additional requirements from zoning issues or previous site problems with municipalities.

- 2. Signal boosting of wireless signals may be needed upon completion of installation. A separate quote for signal extending antenna will be provided if required.
- 3. Due to recent volatile markets and significant price fluctuations, ABM reserves the right to adjust pricing based on the LME copper and LME steel index. If the index increases over 2% from the time of proposal to the time of installation, ABM will apply the market increase percentage to the total price.
- 4. Sales taxes will be charged at time of invoicing and pricing may change due to local tax code and tax status.
- 5. ABM terms and conditions will apply to all stated pricing. Assumes signing ABM contractual documents.
- 6. Pricing valid for 30 days and based upon the above clarifications.
